


Cambridge Coupling Installation Instructions



GENERAL PRECAUTIONS

- Handle parts carefully, do not drop, protect threads
- Avoid loose fitting wrenches
- 3. INSERT STIFFENERS MUST BE USED ON FLEXIBLE PLASTIC SERVICE TUBE OR PIPE
- 4 Pipe must be cut square, clean, round and smooth - Do Not Use A Hacksaw
- Connection type is identified on end of nut 5.
- Always pressure test for leaks before backfilling






